Course Description

Administration of local government services in urban and metropolitan areas. Analysis of particular problems faced by local governments in the performance of line and staff functions.

Individual Papers

Paper 1–Due to be submitted via Blackboard by end of Module 2 on Sunday at 11:59 PM. THIS PAPER WOULD BE APPROPRIATE FOR YOUR STUDENT PORTFOLIO.

Research the agency where you work to find answers to each item listed below. Do not copy text or graphics from a website or other online platform; use your own words for each answer. In a 300-600 word typewritten paper, respond to the following (one-half point per full response to each):

- A) The name of the agency and its principle address. If you work at a location other than the principle address, please indicate that location.
- B) The names and titles of each of the agency's governing board officials.
- C) The names and titles of the agency's chief administrative officer, and each department head who is a direct report to the chief administrative officer.
- D) The total number of full-time and part-time employees in the agency.
- E) The agency's current total expenditure budget amount for the year, in all funds, and indicate whether fiscal-year (with FY end date) or calendar year.
- F) The name and title of the chief Freedom of Information Act (FOIA) officer.
- G) The URL of the agency's primary website, and the name and title of the staff person who is most directly responsible for website management.
- H) The title of the agency's primary Facebook, Twitter, You Tube, and Instagram social media platforms (list as many as applicable).
- I) From the agency's website, name the section or page where you found the following: the next regular governing board meeting agenda, a feedback or "contact us" form, the current budget, and most recent ACFR.
- J) Identify three professional organizations the agency is a member of (i.e. Illinois Municipal League American Public Works Association, Northwest Municipal Conference), and who is the designated representative to each.

Paper 2–Due to be submitted via Blackboard by end of Module 4 on Sunday at 11:59 PM. THIS PAPER WOULD BE APPROPRIATE FOR YOUR STUDENT PORTFOLIO.

In a typewritten paper of 600-900 words, interview your immediate supervisor at the agency where you are either a full-time employee or intern. The paper must include answers and discussion on each of the following topics (one point per full response to each):

- A) Ask the supervisor to discuss their education, previous positions within this agency, and their prior relevant employment.
- B) Ask the supervisor to describe their work typical day, and interactions with their supervisor or to whom they report.
- C) Ask them to describe their relationships with other departments, and other public agencies (schools, park district, library, etc.).

- D) Ask the supervisor to conduct a mini-SWOT analysis of the agency, or the department or organization where you both work, identifying up to three issues for each SWOT (Strengths, Weaknesses, Opportunities, Threats) element, and the reason for each response.
- E) Ask where they see themselves, and this agency, in ten years.
- F) You may ask additional questions, or engage in more topics, as you wish.

Innovations Challenge

Working within your assigned teams, identify, develop and present an innovation for use in a municipal or other local government agency. The goal is to provide a better level of public service for the benefit of the greater community. The idea must be solution-driven, innovative, transferable, and results-orientated. During Module 3, all teams will present their innovation to the class to introduce the innovation and elaborate on the purpose and criteria standards. Presentations, which are between five and ten minutes in length, should include a Power Point presentation of three to five slides to assist in identifying and communicating the innovation. All group members are to share in the presentation equally so all students are included in the process. An information sheet with more details will be distributed.

Team Project: Policy Analysis

Your assigned team will be the team you will work in for the planning, research, writing, and presentation of the team project. The project is to identify and develop a persuasive position on a matter of public policy directly related to local government administration. To this point, avoid matters that deal directly with state and Federal government, or nonprofit management. Research and develop your project based on local government, typically municipal, township, county, or a single-purpose, administration. The objective is to present an affirmative argument in favor of a position relevant to local government, as though you were a work group assigned to make a presentation to the elected officials of the unit of government. The assignment is as follows:

Part 1: Topic (To be submitted via Blackboard no later than end of Module 1 Sun. 11:59 PM). One team member should submit using the assignment link in Module 1 no later than end of Module 1 on Sunday at 11:59 PM identifying your team number, the names of the group members, and up to a one paragraph description of your identified public policy topic for the team project. In the event more than one team selects the same topic, the team submitting the topic first shall be allowed to keep their topic and the other team(s) will select a different topic.

Part 2: Identification Memo (Due to be submitted via Blackboard no later than end of Module 3 Sun. 11:59 PM). In a typewritten, maximum 300 words, paper write a team collaborative memorandum to the governing board stating the public policy topic, its relevance to current issues facing the agency, and a statement of the possible areas you as a work team intend to research and present to the board. The memo should end by identifying the members of the team and their areas of responsibility for the project.

Part 3: Research Paper (Due to be submitted via Blackboard no later than end of Module 7 Sun. 11:59 PM). In a typewritten paper of between 3000-3600 total words (exceeding the word limit will result in deduction of points), excluding a cover page and reference list page(s), present the team's collaborative policy research, to include:

- A) A statement that defines the issue, its importance, the central controversies and options for solutions to resolve the issue. This section should be 600-900 words.
- B) A review of relevant research that provides evidence to support the team's arguments, including problem or issue definitions, elements of the issue, and the alternatives to be considered, both pro and con. This section will include references to literature the team will find as a part of its research, so be sure to use appropriate citations. If the team uses a personal interview as a part of the research, be sure to obtain permission from the interviewee prior to the interview, disclose the purpose of the interview, record the answers, and cite the interview as appropriate. This section should be from 1500 to 2100 words.
- C) The concluding section of the paper will serve as the team's preferred option for resolving or addressing the issue. Restate the policy issue, its relevance and importance to the agency, and the reasons for your recommendation based on the research within the paper. This section should be from 600 to 900 words.

Part 4: Presentation (Due to be submitted via Blackboard no later than end of Module 8 Sun. 11:59 PM). Each team will record a presentation for the class, who will serve as the agency board (via the discussion board), in a 15-minute presentation (exceeding the time limit will result in deduction of points) to summarize the public policy of your research topic, the case analysis and your recommendations. The presentation will include between 5-8 Power Point slides (excluding introduction and citation slides) which summarize the points offered in the presentation.

Blackboard Discussion Forum

We will be using the Blackboard discussion forum as our discussion platform for this course. The link to the discussion page can be found in each module and also in the left menu of the course page. Start by giving an introduction of yourself as your first discussion post.

In each module, a "prompt" will be posted in the discussion forum, based on the guest speaker panel videos you watched in that module. Your task is to respond to the prompt with your own original post, and to respond to two other students' original posts. Points in the discussion forum are awarded weekly based on responding to the prompt with your own original post with a minimum of 100 words (three points), and responding to two (2) other students' original posts with a minimum of 50 words (one point for each response; two points possible).

The total number of points for the discussion forum each module week is five (5) points. For the course, the total number of points possible is 35 (5 points per module for seven modules). Original posts, and two response posts, are due by 11:59PM Sunday at the end of the module week.

Guest Speaker Panel Videos

During a previous semester of PSPA 632, twenty local government professionals appeared as guest speakers, mostly in a panel discussion format, and tour guides. These speakers were invited to discuss their backgrounds, what lead them to their respective local government position, or former position, and what a typical day is like for them in terms of their interaction with stakeholders and agencies. Following the speakers' presentations, students in the class asked questions of the speakers. For this online class, you will watch these videos, and the question and answer period that followed. The guest speaker videos will be the basis for the discussion forum for the respective module. Be sure to watch all the videos listed, and the question and answer video for each module. There are no guest speaker panel videos in Modules 1 or 8. The modules, topics, and guest speakers are:
